



D.C. keeps its title as the country's #1 city for parks. The Trust for Public Land says that 99% of D.C. residents live near a park, and 24% of city land is used for parks. There are a total of 697 parks and green spaces.



#### DID YOU KNOW THIS ABOUT THE DC SKYLINE?



DC's unique and picturesque skyline isn't just by chance but by legislative design. Washington, DC is renowned for its distinctive skyline, which is largely defined by the Height of Buildings Act of 1910. This crucial piece of legislation restricts the height of buildings in the nation's capital, preserving the historic and aesthetic character of the city.

The rule is that no building can be taller than the width of the adjacent street plus 20 feet. In practice, this means most buildings in the central areas of Washington, DC do not exceed 130 feet, with few exceptions. This adds an invaluable layer to the quality of life and the aesthetic experience of both residents and visitors, further underlining why Washington, DC is such a desirable place to live and invest in real estate.

#### **Summary for Newcomers to Auction Houses**

**Lowered Fees:** We've reduced the Buyer's Premium by 26% on almost all items and removed the 1% Overhead Premium fee.

**Positive Feedback**: A survey showed that 90.6% of clients are likely to bid higher with the new lower fees.

**New Rates**: Effective May 20, the Buyer's Premium is now a flat 20% for lots up to \$6 million and 10% for any portion above \$6 million, the lowest in the industry.

**Upcoming Auctions:** The new fee structure applies globally, except for real estate, automobiles, wine, and spirits. Explore our upcoming auctions in various categories like British & Irish art and Magnificent Jewels.
